## **Market Update**

### Equity

Ukrainian equities edged down on Tuesday (Jun 4) in a low-energy session in which none of the major names moved by more than 1% in either direction, against a backdrop of minor gains on the main European indices. The UX index fell 0.3% to close at 856 points. CentrEnergo (CEEN) and Raiffeisen Aval (BAVL) both slipped by 0.9%, while volume leader Motor Sich (MSICH) was unchanged on turnover of UAH 3.4mn. DonbasEnergo (DOEN) showed a mild outperformance, adding half a percent to UAH 20.80 on the possibility that a privatization auction for the company may finally be announced in August of this year. In London, agro giants MHP (MHPC LI) and Avangard (AVGR LI) were marginally higher by less than 1% each, while Ferrexpo edged lower by 0.9%. In Warsaw, Astarta (AST PW) jumped 4.2% to PLN 60.05 on what appeared to be a single deal in afternoon trading.

### **Fixed Income**


Ukrainian sovereign Eurobonds were mixed on Tuesday. Ukraine-23s inched up by 0.1p.p. closing at 96.9/97.8 (8.0%/7.8%) while Ukraine-17s edged down by 0.1p.p. to 98.8/99.8 (7.1%/6.8%). Corporate names were mostly down. MHP-20s declined by 0.2p.p. to 97.3/98.3 (8.8%/8.6%) and Metinvest-18s slid even further by 0.5p.p. to 99.9/100.6 (8.8%/8.6%).



# Alchevsk Steel Posts Output Rise of 11% MoM in May

### **NEWS**

Alchevsk Steel, Ukraine's fifth largest steel mill, increased its steel production by 11.0% MoM to 369,000 tonnes in May, Interfax reported on Tuesday (Jun 4). Compared to May 2012, the company's crude steel output was up by 10%. Year-to-date (through May), Alchevsk has expanded its output by 13% YoY to 1.8mn tonnes.

### **COMMENTARY**

We see the news as positive for the ALMK stock, which remains at a heavily depressed level along with most other locally-listed blue chips. We presume that an improving order book and relatively less exposure to the European market than its domestic peers is allowing Alchevsk to post operational results that are significantly better than the average Ukrainian steel sector statistics. Overall, the domestic steel sector posted a 0.8% MoM increase in output in May and a 5.5% YoY drop. Year-to-date, Alchevsk has demonstrated the strongest improvements in operational results among the 7 largest Ukrainian steel producers. The company plans to further expand its steel output by 4% MoM to 385,000 tonnes in June, according to the Ministry of Industrial Policy.







