Market Update

Equity

Ukrainian equities were rather quiet on Thursday (Apr 3) in line with the behavior of the headline global indices, with only the Nasdag-100 (-0.9%) showing any notable movement among the main bourses in the US and Europe. The UX index declined by 1.1% to close at 1064 points, pulled down by a 3.8% correction in high-flying Raiffeisen Aval, which remains up by double digits for the week. Co-volume leaders Motor Sich and CentrEnergo moved in opposite directions, with the former losing 1.1% and the latter rising by the same increment to UAH 5.45; the issues registered turnover of UAH 3.2mn each. Outside the UX basket, Slavutich Brewery, the local subsidiary of Carlsberg Group, saw some fairly substantial trades at UAH 8.50, representing a 13.1% jump from its previously listed price. Ukrainian names in London continued to have a quiet week, with MHP and JKX Oil&Gas closing nearly unchanged and Ferrexpo edging up 1.1% to GBp 160.

Fixed Income

Ukrainian sovereigns were down on Thursday. Ukraine-23s declined by 0.8p.p. closing at 92.6/97.1 (8.7%/8.0%). Meanwhile, corporate names were mixed. DTEK-15s advanced by 8.6p.p. to 95.3/98.0 (16.7%/13.2%) while Ferrexpo-16s dropped by 0.3p.p. finishing at 96.2/97.7 (10.6%/9.5%).





Poroshenko Calls For Cancellation of Gazprom Contract After New Price Hike

Presidential front-runner Petro Poroshenko on Thursday (Apr 3) called for Ukrainian state energy monopoly Naftogaz to file a motion in the Stockholm Arbitration Court to cancel the 2009 pricing formula contract with Russia's Gazprom, Interfax reported. Poroshenko's statement came after Gazprom CEO Aleksey Miller announced a rise in the price for Ukrainian gas importers from USD 385 to USD 485 per 1,000 cubic meters (cu-m), based on the 2009 contract and the voiding of a USD 100 discount related to the Black Sea Fleet basing rights in Crimea. The discount had been granted to Ukraine in April 2010 in return for using the Sevastopol port to host Russian naval fleet. On Wednesday (April 2), President Vladimir Putin signed a law ending Russia's commitment to the so-called Kharkiv Agreement, as the Black Sea port of Sevastopol is now under the jurisdiction of the Russian Federation after the de-facto annexation of the Ukrainian province of Crimea.

COMMENTARY

We agree with Poroshenko's view that Naftogaz has a good chance to win an annulation of the 2009 contract in Stockholm based on its lack of correspondence to today's gas market conditions; gas importers from several other European countries have already used litigation to force Gazprom to renegotiate the terms of their deals. The price hike itself was quite expected (please see Eavex Daily from Apr 1). The new price of USD 485 will be the highest in Europe, which is economically nonsensical taking into account the lower delivery costs for Ukraine compared to Gazprom's customers further west. Newly-appointed Ukrainian Energy Minister Yuriy Prodan, who previously served in the same post in the government of Yulia Tymoshenko during 2007-09 (it was the Tymoshenko government that signed the problematic 2009 contract), said the country is ready to buy re-exported gas from the EU, in particular from Poland. The relationship between Naftogaz and Gazprom has a clearly political context and the future price for imported Russian gas will depend on how successful Ukrainian authorities are in negotiating with the Kremlin. However, an additional impediment to a normal business relationship between Naftogaz and Gazprom is a USD 2.2bn debt owed by the Ukrainian side for gas that was delivered in 2H13 and 1Q14.




